**A motion was made by Commissioner Vezzani and seconded by Commissioner Cisneros to approve minutes of August 25, 2019. Motion passed by unanimous vote.**

County Administrator John Galusha and the Board reviewed action items.

**A motion was made by Commissioner Cisneros and seconded by Commissioner Vezzani to hire Jillilan McCleary as an Income Maintenance Technician II at a salary of \$2,025.00/month starting September 8, 2015 going through the County Hiring Process. Motion passed by unanimous vote.**
