  concrete foundation must be cut down to 12" below grade within ninety
  (90) days.
- 2. An access permit approval must be acquired from the Colorado Department of Transportation prior to construction of the tower.
- 3. Issuance of building permits and the construction of the tower must begin with 180 days of Conditional Use Permit Approval.
- The lease agreement between Mr. & Mrs. Bossert and Mainstreet
   Broadcasting must be recorded in the Office of the Huerfano County Clerk

- & Recorder and submitted to Land Use Staff. A redacted copy is acceptable.
- A compliance review with staff must be completed after one (1) year from the date of Conditional Use Permit approval.
   Motion passed by unanimous vote.

A motion was made by Commissioner Vezzani and seconded by Commissioner Cisneros to sign Temporary Easement between Norman & Joanne Abair and Huerfano County Government regarding County Road 104. Motion passed by unanimous vote.
