A motion was made by Commissioner Cisneros and seconded by Commissioner Vezzani to approve the minutes of April 4, 2017. Motion passed by unanimous vote.

A motion was made by Commissioner Cisneros and seconded by Commissioner Vezzani to adopt RESOLUTION #17-45, A RESOLUTION RECOGNIZING JOSE B. L. SANDOVAL AND PROCLAIMING APRIL 21, 2017, AS "JOSE B. L. SANDOVAL DAY" IN HUERFANO COUNTY, COLORADO for his service in the United States Marines. Motion passed by unanimous vote.
