March 20, 2018**

Chairman Ray Garcia called the meeting to order followed by the Pledge of Allegiance.

Commissioners Gerald Cisneros, Ray Garcia and Max Vezzani were present.

A motion was made by Commissioner Cisneros and seconded by Commissioner Vezzani to approve the March 13, 2018 minutes. Motion passed by unanimous vote.

10:11 A.M. Richard Goodwin met with the Board asking the county if they would create a map showing the location of marijuana grows located in Huerfano County. He also asked the County if they would post the 2018 Budget and new marijuana regulations on the county website.

A motion was made by Commissioner Vezzani and seconded by Commissioner Cisneros to re-hire Anthony Vallejos as a Seasonal Truck Driver/Laborer position with Road & Bridge cattle guard crew at \$15.50 an hour. Motion passed by unanimous vote.

A motion was made by Commissioner Vezzani and seconded by Commissioner Cisneros to hire Steven Bell as a Seasonal Truck Laborer with Road & Bridge, contingent upon required background check and employment drug test with a negative result. Mr. Bell must also acquire a valid Colorado Drivers License. Motion passed by unanimous vote.

Building Authority Board time to review the applicants. Motion passed by unanimous vote.

A motion was made by Commissioner Vezzani and seconded by Commissioner Cisneros to approve RESOLUTION #18-33, A RESOLUTION APPOINTING DEB KNOTT TO THE CUCARA MOUNTAIN PARK ADVISORY COMMITTEE FOR A TERM EXPIRING ON DECEMBER 31, 2019. Motion passed by unanimous vote.

County Administrator John Galusha and the Board reviewed action items.

A motion was made by Commissioner Cisneros and seconded by Commissioner Vezzani to hire Sage Electric to complete electrical work at the Gardner Shop to replace an 8' fluorescent light fixture with a 4' LED strip light and install wiring and two ceiling fans in shop area in the amount of \$615.00. Motion passed by unanimous vote.

Skylar Walker owner of Pharm Aide Pharms met with the Board in regard to the outdoor marijuana grow regulations as adopted by the county.
