Commissioners' Meeting September 4, 2018

Chairman Ray Garcia called the meeting to order followed by the Pledge of Allegiance.

Commissioners Gerald Cisneros, Ray García and Max Vezzani were present.

A motion was made by Commissioner Cisneros and seconded by Commissioner Vezzani to approve the minutes of August 28, 2018. Motion passed by unanimous vote.

A motion was made by Commissioner Vezzani and seconded by Commissioner Cisneros to approve extending employment of seasonal applicator Rod Smircich until October 31, 2018 due to the two week delay from the Spring Fire and the expanded weed spraying season. County Administrator John Galusha will monitor the weather and decide if there is a need to continue with his employment. Motion passed by unanimous vote.

A motion was made by Commissioner Vezzani and seconded by Commissioner Cisneros to move Richard Martinez from full time at the Waste Transfer Station, starting September 4, 2018 to 3 days a week and 2 days a week at Road & Bridge and his pay would be prorated 60% Waste Transfer Station and 40 % Road & Bridge. Motion passed by unanimous vote.

A motion was made by Commissioner Vezzani and seconded by Commissioner Cisneros to approve Abatement #18-46 on behalf of Robert Loeffler in the amount of \$3.06 for the 2016 tax year and \$3.54 for the 2017 tax year. Motion passed by unanimous vote.

A motion was made by Commissioner Vezzani and seconded by Commissioner Cisneros to remove the Stage 1 Fire Restrictions based on the numbers currently given to the Board. Motion passed by unanimous vote.

County Administrator John Galusha and the Board reviewed action items.
