A motion was made by Commissioner Vezzani and seconded by Commissioner Cisneros to approve the following Abatements:

- #18-48 on behalf of Will & Janet St. Jacques in the amount of \$397.54 for the 2016 tax year and \$171.64 for tax year 2017.
- #18-49 on behalf of Corp of Presiding Bishop of the Church of Jesus Christ of LDS in the amount of \$13.39 for the 2017 tax year.
- #18-50 on behalf of Corp of Presiding Bishop of the Church of Jesus Christ of LDS in the amount of \$10.02 for the 2017 tax year.
