Rules and Regulations – Alcohol Consumption

REGULATIONS CONTROLLING THE POSSESSION
AND CONSUMPTION OF ALCOHOL IN AND UPON
HUERFANO COUNTY MANAGED FACILITIES

SECTION 1

GENERAL PURPOSE

Control of Alcoholic Beverages. The purpose of the Rules and Regulations regarding alcohol consumption is to control the possession or consumption of alcoholic beverages in, on or about property which is owned by Huerfano County, and as identified in Section 2 Item 1 below. The Board of County Commissioners has determined that these Rules and Regulations regarding alcohol consumption are in the best interests of the County and person(s) utilizing County owned facilities.

SECTION 2

SUPPLEMENTATION

ITEM 1:

COUNTY PROPERTY RESTRICTION.

No alcoholic beverages shall be carried upon, possessed or consumed within or upon any properties owned by Huerfano County, which have been designated as public parks, playgrounds, community centers or any other property which has been dedicated for public recreational purposes, except as provided in Section 2 item 2.

ITEM 2:

REQUEST FOR PERMIT.

Any person, corporation or group wishing to conduct a function on Huerfano County property described in Section 2, Item 1 of these Rules and Regulations, at which alcoholic beverages may be consumed, shall submit a written request, upon a form supplied by Huerfano County, substantially the same as that form attached to these Rules and Regulations, and titled APPLICATION FOR PERMIT FOR CONSUMPTION OF ALCOHOLIC BEVERAGES ON PROPERTY OWNED BY HUERFANO COUNTY, to the Huerfano County Board of County Commissioners. Such permit shall be granted or denied by the Huerfano County Board of County Commissioners.

ITEM 3:

SALE OF ALCOHOLIC BEVERAGES.

Alcohol may not be sold on any County owned property as outlined in Section 2 Item 1 unless the renter of said facility has obtained the proper authorization and licenses from State and Local authorities. It is the sole responsibility of the renter to determine what licenses are required and to obtain the proper legal authorization.

SECTION 3
CONSENT.

Any person going upon any property described in Section 2 Item 1 of these Rules and Regulations which is owned by Huerfano County shall be deemed to have consented to the terms contained in the Rules and Regulations regarding alcohol consumption and any person violating any section shall be considered a trespasser and shall be dealt with as prescribed by law.

SECTION 4
LIABILITY.

Renters and users must assume all liability for any accidents or mishaps that may occur on any County owned property as described in Section 2 Item 1, as the result of the consumption of alcohol while on the property. Huerfano County Government cannot be held responsible for any alcohol related problems that may occur as a result of alcohol consumption by users, renter, or their guests. In particular, renters and users of Huerfano County owned facilities/grounds must also assume responsibility for any accidents or mishaps that result from the consumption of alcohol that is brought onto the property by their individual guests.

SECTION 5
NOTICE.

Renter shall post at the event location, for the duration of the event the “Rules and Regulations – Alcohol Consumption” and a copy of their approved “Application For Permit For Consumption Of Alcoholic Beverages On Property Owned By Huerfano County” which applies to their respective function/event.

SECTION 6
NOTICE TO SHERIFF.

A copy of the “Rules and Regulations – Alcohol Consumption” information shall also be furnished to the Huerfano County Sheriff to notify their agency should violations of these rules occur, the Sheriff’s Department shall be called upon to take appropriate action against such violators.
