#### HUERFANO COUNTY DRIVEWAY ACCESS PERMIT APPLICATION

All applicants requesting driveway access within unincorporated areas of Huerfano County, must obtain and have completed a Huerfano County "Driveway Access Permit Application". Access requests must be completed for property access from the County maintained road system, and prior to the issuance of a building permit by the Huerfano County Land Use Office. This requirement has been enacted to insure the access provides for proper and safe traffic flow, unrestricted drainage and protection of the public roads.

#### The procedure and general provisions for issuance is as follows:

1. Applicant shall submit a completed driveway access permit application with appropriate site plan which depicts existing structures, lot lines, location of proposed access, any existing access and proposed improvements, and an arrow indicating North at top of page. Submit to:

- 2. Construction of the access(s), if granted, shall comply with Article 7 Roadway Access of the Huerfano County "Roadway Design and Construction Standards". Access permit applications shall be issued only in compliance with this article.
- 3. The Construction Inspector will inspect the proposed access and inform the applicant if the proposed plan is satisfactory, what additional requirements must be met and to determine what, if any, public improvements are required. The executed permit copy will then be mailed to the applicant's address shown on permit.
- 4. All construction within the County right-of-way shall be performed **only by a contractor licensed** with the Huerfano County Regional Building Authority. The applicant is responsible to call for an underground utility locate before starting excavation.
- 5. The applicant shall furnish all materials required for any work to be done in conjunction with the construction of the driveway access i.e. concrete, rebar, Class 6 base material, culverts, and any other materials required.
- 6. Adequate traffic control and construction signing is required at all times during construction of the access. Adjacent lots and public roads shall not be disturbed or damaged by construction or equipment.
- 7. Driveways shall conform to the geometric standards illustrated in Appendix 1, Figures 21 through 23. Any variation from the requirements shown due to physical site restrictions or unusual circumstances must be approved by the Board of County Commissioners.
- 8. The property owner shall assume responsibility for culvert maintenance and for the removal or clearance of ice and snow from the driveway even though it may be deposited by the District in the course of snow removal.

# **SPECIAL PROVISIONS**

#### To be completed by Construction Inspector:

A. SWALE ACCESS.
For gravel roads. Excavate to 9 (nine)-inch depth from property line to edg of road. Following the contour of the ditch line, bring back up to existing flow line with Class 6 (six road base.
Distance in feet from nearest intersecting road:
For paved roads. Excavate down to 4 (four) inches from property line to edge of road. Following the contour of the ditch line, driveway access shall be 4 (four) inches concrete or asphalt, with 10 foot radius returns.
Distance in feet from nearest intersecting road:
B. <b>CULVERT ACCESS.</b> Minimum culvert size shall be 18 inch equivalent or larger a determined by the County Inspector.
For gravel roads. The applicant shall install a foot byinch diameter annular (CMP) corrugated metal culvert pipe in the flow line of the drainage ditch. Class (six) base materials shall be compacted to a depth of 6 (four) inches under the pipe to bed it an bring it to grade. A minimum of 12 (twelve) inches of compacted Class 6 (six) cover over the pipe Both ends of pipe are to have concrete end treatments.
Distance in feet from nearest intersecting road:
For paved roads. The applicant shall install a foot by incommendation in the diameter annular (CMP) corrugated metal culvert pipe in the flow line of the drainage ditch. Class (six) base materials shall be compacted to a depth of 6 (four) inches under the pipe to bed it an bring it to grade. There shall be 4 (four) inches of concrete or asphalt cover over the pipe with 10 for radius returns. Both ends of pipe are to have concrete end treatments.
Distance in feet from nearest intersecting road:
<b>PRE-INSPECTION:</b> A pre-inspection is required to ensure that all terms and condition comply with "Article 7". Please allow 24 hours from call to inspection. <b>NO EXCEPTIONS</b>
FINAL INSPECTION: 24 hour notice required prior to final inspection. <i>NO EXCEPTIONS</i>

CONSTRUCTION OF THE ACCESS SHALL BE COMPLETE AND ACCEPTED BY THE COUNTY INSPECTOR BEFORE THE ACCESS IS USED FOR ITS INTENDED PURPOSE. THE PERMIT WILL EXPIRE IF CONSTRUCTION IS NOT COMPLETED WITHIN 6 MONTHS OF APPLICATION DATE. RE-APPLICATION WILL BE REQUIRED.
