Request for Copy of Report

The Huerfano County Sheriff's Office releases copies of all reports <u>by mail or fax only</u>. Please read the instructions below and complete the application on the reverse side of this form. If all sections are not completed, your request will be denied. Any notarized letters, signed waivers by clients, etc. must be attached. Reports requested on behalf of a business should include documentation that the requester is entitled to receive the report.

Report requests are processed in 10 working days upon receipt. Please note that there is an internal approval process and Reports are not available for release until this process is completed. Requests may be submitted by mail, dropped off at the Sheriff's Office, or by fax.

The fee is \$5.00 for reports and \$25.00 for photos (per CD or report). Payment may be made by cash, cashiers check or Money order. Please make checks payable to the Huerfano County Sheriff's Office. Please do not mail cash. All requests will be reviewed and you will receive your report or notification of denial within 10 working days from the date your request is Received, plus mailing time. Payments are processed at the time of request approval.
